### **President's Report**

### 21 August 2024

For those that haven't met me before, I'm Tom.

I have been actively involved with EnvA since it was first established two years ago. But this is my first President report, as I only took over the role from James York a few months ago. James - thanks for your help putting my report together!

I also send my thanks to James for his 20 months as EnvA's President – and am very happy to say that James has continued his role on the management committee and is a fantastic supporter of EnvA and our work.

Habitat loss and climate change are the two biggest threats to koalas. Coal mines significantly contribute to both!




Koalas or coal mines: how the federal government can help protect Australia's most iconic species (Koalas not Coal, August 2024)

### What we can say...

### Blue Energy have changed their project

Blue Energy has withdrawn their application for Lancewood and Central and are only focused on the Sapphire lease ©

### EnvA's ongoing case

We are still raising serious concerns about Blue Energy's proposal, including significant impacts to groundwater and biodiversity.

Blue Energy's initial application did not contain an assessment of greenhouse gas emissions, so we are asking for improved assessment of the project to ensure that the GHG emissions are properly calculated, and the contribution of Blue Energy's proposal to climate change is properly assessed.

EnvA is also raising concerns in relation to misinformation put forward by the petroleum and gas industry about the need for any new gas projects in the transition to net zero.





### Reep Blue out of CQ 🏚

### What are the next steps?

The parties have now nominated their experts who will provide evidence in the proceedings.

There will be some out of court meetings for the experts to pin down the areas that the parties can agree to, and areas where the court will need to hear the evidence and decide the merit of the project approval.

The 'real' court hearing probably won't happen until at least March next year.

### Fixing legislation and policy

Some of Qld's legislation and policy is flawed and is resulting in poor outcomes for the environment. 📀

Our campaign started with obvious issues with how DESI was using the guideline to determine whether an EIS was required.

Coal companies were splitting their projects into small pieces to avoid triggering the coal volume trigger.

As we continue to review projects for submissions, we keep finding even more issues that need fixing.

### What we have been doing in this campaign?

- Lots of letters to government!
- Including our concerns in relevant submissions
- Requests for assessment reports (CAC reports)
- Lots of meetings and conversations with DESI

### The standard response

"We always do a thorough assessment of every project regardless of whether and EIS is required or not"

### We do think we are making a difference!

We haven't managed to change the guideline, but we have made them more attentive to using the whole guideline and not just the coal volume trigger.

Proponents are now being asked for further information and having to include GHG emission calculations and decarbonisation plans.

### Keep Blue Energy out of CQ





- Continue our legal challenge
- The Land Court process is expected to be finalised by May 2025.
- Hopeful the Land Court rules in our favor, but if not, we will need to review the decision and decide whether to take the challenge to the Supreme Court.
- Where we can, we will also make submissions and comment on other coal seam gas projects in our region.

### **Koalas not Coal**

- Koko to take a lead role at events and in social media.
- ► At least one event based on 'koalas not coal' - maybe a float at Pinefest.
- Social and general media where koalas will be significantly impacted by coal mines
- Continue involvement in the National Koala Recovery Action Plan.



### No new coal or gas

- Continue to make submissions on as many proposed coal and gas projects as possible.
- Maintain our role in regular:
  - CQ Coal catchups,
  - Meetings with DESI on CQ coal mines
  - Meetings with the Queensland Mine Rehabilitation Commissioner, and
  - Consultation with the Reef Water Quality Improvement taskforce.
- And maybe take on another legal challenge against a coal project!



Fixing legislation and policy

- Contribute to the EPBC review and make it easy for everyone to have input.
- Continue to write to decision-makers when the processes aren't protecting the environment.
- Write to welcome the next Qld Environment Minister and make sure they are aware of our issues with Queensland's legislation and policy.
- Contribute submissions to any amendments to legislation, policy and guidelines related to EnvA's campaigns. (i.e. the Mining lease objections review).
